AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters that we communicated to District management and the Board of Directors in a letter dated April 23, 2020, related to procurement requirements. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Yakima School District No. 7 from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Student enrollment reporting
- Establishment of local revenue and expenditure accounts
- Use of restricted funds professional learning
- Self-insurance for unemployment and workers compensation
- Procurement public works and purchases

- Payroll Special education overload payments, retroactive payments and optional contracts
- Accounts Payable electronic fund transfers and credit cards
- Associated Student Body activities fundraisers, inventory and cash receipting
- Cash receipting timeliness and completeness of deposits at the District's office

INFORMATION ABOUT THE DISTRICT

Yakima School District No. 7 operates 24 schools to provide educational services to approximately 15,700 students in Yakima County. Services include basic elementary, middle school, high school, vocational education, technical skills center, alternative schools, bilingual education, pupil transportation, food services, special education and remedial and enriched education programs. In addition, the District provides transportation vehicle repair services.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations as well as its 1,994 full- and part-time employees. The District operates on an annual budget of approximately \$250 million.
